RABBI ALAN LONDY



CURRENT TUITION, MEMBERSHIP, AND HIGH HOLY DAY POLICIES AT NRT

Tuition Policy for Members:

Members of NRT may enroll their children in our Religious School at a tuition rate of \$100.

Tuition Policy for Non-Members:

Torah Tots, our Sunday preschool program, is free. It is open to all Jewish families in our community.

Beginning with kindergarten, a family may enroll their children in our Religious School for one year without being a member. They pay the non-member tuition of \$200.

After one year, the family must become a full dues[1] paying member in order for the child to continue in our religious school.

Tuition Policy for Members of Kol Ami:

Members of Kol Ami are permitted to enroll their children into our Religious School at a non-member rate. They are not required to become members at NRT but must remain members of Kol Ami.

High Holiday Ticket Policy for Non-Members:

For security reasons, all people attending our worship must have in their possession a High Holy Day ticket.

Tickets will not be issued at the door or sent in the mail.

The tickets can be obtained prior to the Holy Days without charge.

(A donation of \$100 is suggested for each ticket.)

To obtain a ticket, a person must come to the synagogue office prior to the High Holy Days. An information form must be filled out for the membership committee to follow up with the guest.

Obligations to other synagogues:

A person who has not fulfilled their financial obligation to another congregation cannot become a member of NRT until that obligation has been met.

Associate Memberships:

Associate Member must be, at the time of application, a member in good standing at another synagogue. (Status of membership will be checked before associated membership is approved.)

Associate Member will pay 50% of NRT's synagogue dues according to most current dues structure of the synagogue.

Associate Membership must be approved by the Board of Directors.

Privileges:

Participating in synagogue worship including High Holy Days

Participation in all synagogue educational, cultural, and social programming.

Enrolling child(ren) in religious school at the non-member tuition rate.

Receiving all congregational mails and electronic communications.

Exceptions:

NRT clergy may not officiate at the associate Member's life-cycle events without prior permission of the rabbi from the synagogue of primary affiliation. Appropriate fees, set by the board, will be charged by the synagogue when NRT clergy are asked to perform life-cycle events.

Associate member may not serve on the Board or Congregation Committees.

Associate member may not vote at a congregational meeting.

[1] In certain circumstances, reduced dues can be arranged in consultation with the President or the Treasurer.
